Birth Photography Contract-Package Deal

Tell them you're my client and they need to get ahold of me right away for you.

Thank you for choosing Jenny's Childbirth Services to capture the special moments of your labor process and the arrival of your new little one!

Birth and labor are very unpredictable and therefore these are not typical portrait sessions. The lighting may be dim, and planning what's going to happen can be difficult, it is understood that some photos may be grainy due to lighting. I will photograph your labor and birth as it unfolds. I will be sensitive to your needs as a laboring woman and I understand my role to document quietly and unobtrusively.

Birth Photography Package

- I will be on call 2 weeks before & 2 weeks after your due date
- I'm there during labor, birth and immediately after birth
- 75-150 edited photos
- Your photos will be available to you within 2 weeks

Payment and Logistics

The total for your birth session is \$500

- a non-refundable \$125 deposit is required to secure your due date
- the remaining \$375 is due 4 weeks before your due date

It's helpful for us if you check in after doctor's appointments in the weeks before labor and let us know how things are progressing and/or if there will be any changes to your initial birth plan.

'It's Time!'

Please contact me as soon as you *think* you might be in labor so I can begin making plans to get to you. Even if it's 2am. Even if it's a false alarm. I'd much rather be ready to roll than to miss the event!!!

Have someone contact me again when it's confirmed that you're in labor (when you're about 3-4cm), and I will start making our way to your home, birthing center or hospital.

*If you are expected to have a very quick labor or have a history of quick labors, please circle yes or no below and also let us know when you call so we can come right away!

I give my permission for Jenny's Childbirth Services to share my and my child's name and images through their website, brochures and social media, etc.

Terms of Service

Limitation of Liability: While every reasonable effort will be made to produce and deliver outstanding images of the event, the photographers entire liability to client for any claim, loss, damage, or injury arising under or relation to the agreement of the photographer's performance hereunder, including the negligence of the photographer, is limited to a refund to client of all fees paid for services.

Since the timing of births is so unpredictable, I cannot guarantee that I will be able to make the birth. If I or my backup can't make it (due to unforeseen reasons such as illness, weather, etc.) all monies paid will be refunded.

If we cannot provide these services as a result of your actions or due to circumstances beyond anyone's control (i.e. failure to provide adequate notice of the baby's birth, unexpected transport for cesarean etc.) the second part of your payment will be refunded.

Cancellation

If you decide to cancel my services for any reason before you're 36 weeks pregnant, your initial deposit is non-refundable. After the remainder of the payment has been made when you're at 36 weeks there will be no refunds.

We take the utmost care with respect to the post-production and delivery of all photographs. However, in the event that we fail to comply with the terms of this agreement due to any even or act which prevents the delivery of the photographs from the birth, our liability to you is limited solely to a refund of all money paid.

Copyrights

I reserve the right to use any image for display, publication, or other purposes; however we will honor any requests by the family for using, or not using certain images when necessary. You will receive a copyright agreement that allows you to reprint any images for personal use. You may not sell these images or use them for any commercial use without the written approval of the photographer.
